Project GATeWAY June 2023 Update



UK's research grants administration operations were assessed in 2022 as a part of Project GATeWAY (Grants Administration Transformation as the WAY Forward). In January 2023, three strategic opportunities from the assessment – Structure, Collaboratives, and Technology – began being implemented. Currently the project is in the Design Phase, the first of four phases (Design, Build & Test, Implement, and Optimize) to transform research and grants administration.

WHAT YOU NEED TO KNOW

- UK Research Administration is moving to a shared services model for local grants administration. A new organizational structure, **Collaboratives**, will be developed, along with new job architectures, business processes and staffing, to provide opportunities for growth, continuing education and pathways for career advancement for administrators.
- The project is currently in the Design Phase and has included thoroughly mapping current state business processes. We are beginning to design the future state, which will increase our efficiency and support our grants administration staff. Several working groups are supporting the design and development of the services to be provided by the Collaboratives. We are set to have a directional model in late June.
